Our representative to the Annual AWCI meeting, Lloyd Lehn, produce financial reports that revealed the financial problems our National organization is experiencing. We still need to focus on electing a responsive Board, two members at a time.

So much for the serious times, I feel like a little fun at the Convention. Thanks again for you support and I look forward to seeing you in Lynchburg this April. Lowell

# Draft Minutes of the March 4, 2007 HAV Board of Directors Meeting - Courtesy of HAV Secretary, Lloyd Lehn, CC

Editor's note: These minutes will be draft until approved at the next HAV Board meeting.

1 Call to Order/Attendees. Lowell Fast called the meeting to order at about 10:10. This meeting had originally been scheduled a week earlier but was moved because of bad weather. Attendance suffered as a result. When we arrived, the motel was operating on an emergency generator but we had lights in our meeting room. The power came on before we left.

**2 Invocation.** Wayne Simpson gave the invocation.

**3 Add/Delete Agenda Items.** Discussion of a HAV Web Page was added to the agenda.

#### 4 Officers Reports.

**4.1 Secretary - Minutes.** The minutes were approved as distributed.

**4.2** Secretary - Organization Chart. Lloyd asked the Board to provide any corrections to the HAV organization chart.

#### 4.3 Treasurer's Report.

Stan provided a copy of the HAV finances as of 4 March. HAV has \$16,037.06 available.

Stan may roll all of our funds into a single no charge account if one of the banks starts to charge us for having an account.

#### 5 Continuing Business.

#### 5.1 Convention Plans.

Steve Leonard provided an overview of the plans for the April Convention and a financial analysis. If the assumptions are correct, we will have a shortfall of around \$900 for the Convention.

Members full registration is \$95 and spouses is \$70 for the weekend. Motel rate is \$69 + taxes for early registrations.

Guild representatives are encouraged to remind their members to register early - especially at the hotel since there is a major sporting event being held in Lynchburg that weekend.

#### 6 New Business.

6.1 AWCI Annual Meeting Representative Funding.

Two motions were offered, discussed, and voted on concerning funding reimbursement of the HAV representative to the AWCI annual meeting.

#### 6.1.1 Tri City Guild.

Bob Bruckhart, said the Tri-City Guild asked him to submit the following motion. "Move that the HAV delegate to the AWCI Annual Business Meeting be reimbursed by HAV for only the cost of registration and lodging expenses." "This was prompted in response to recent years double delegate attendance and related expenses and is in connection with HAV's ebbing membership and also lack of

punch for our buck with AWCI's Board of Directors." The motion was seconded and discussed at some length. The motion failed 6 to 2.

#### 6.1.2 Subtopic.

Ralph Smith offered the following. Moved that HAV pay the all the expenses of the HAV representative to the annual meeting (e.g. travel, registration, meals, other expenses). The motion was seconded and a shorter but comprehensive discussion followed. The motion passed 9 to 1.

#### 6.2 Web Page.

Lowell Fast brought up the need for an HAV web page. There was a short discussion about what "a web page" effort would entail and what should be on the web page. Stan Palen, Lowell Fast, and Lloyd Lehn we named as an ad hoc committee to put together some sort of definition/requirements package for an HAV web page. They are to report at the April Board meeting so the Board can review it.

#### 6.3 Projector.

Steve Leonard suggested that HAV might want to buy a PC projector since it costs us \$200 to rent one for the convention weekend. The group informally discussed the issue. Bob Bruckhart expressed concern/experience about buying electronic equipment that becomes obsolete in short time. We have been borrowing them for several years. No action plan was put in place to buy a projector.

#### 6.4 HAV Publicity.

George Evans thanked those responsible for getting HAV some publicity in a recent issue of AWCI's Horological Times. The HT Affiliates column featured several paragraphs about and a picture of the attendees at the HAV Fall Seminar.

#### 6.5 Board Meeting Site.

It was suggested that the cost of holding our meetings at the Holiday Inn is perhaps a bit excessive. While several people offered suggestions, no plan of action was put in place to search for an alternate site.

**7 Board Meeting Plans.** The next meeting will be held at the convention on Sunday after lunch. The meeting adjourned at about 1205.
